Later on, of course, gradually and slowly the people of the locality acknowledged the crucial situation and mesmerized for the prospects and building a college. Thus, with untiring spirit and zest finally the said college got birth in the womb of greater Udali by dint of some prominent educationist and politicians.

Due to the active involvement in disseminating knowledge and quality education, Gauhati University extended permanent affiliation in the year 2011 for the ongoing Arts Course. Curricular Aspects

Since the College has been affiliated to Gauhati University, It politely follows the curriculum designed and developed by the aforesaid University. The Academic Calendar of the college is prepared in conformity to the general Academic Calendar provided by the University with some modifications to suit out courses and condition for affective transaction of curriculum. The Departments maintains departmental log book, and along with departmental routine. The college takes regular counselling and monitoring System monthly in order to gather feedback from its students for the better implementation at the curriculum.

Teaching-learning and Evaluation

The college tries its level best to improve the teaching - learning process. The process of teaching and learning interact in a way that learners work for their goals and they learn new knowledge, behaviours, and skills as their learning experiences.

Provisions are also made for differently able students to have easy access to class rooms. The college faculty love learning and teaching and urge to be in a learning environment. They take regular classes and full responsible on their duties. They are fully Co-operative and friendly with the students. They maintain classes as per the Schedule of the class routine by the Routine Committee. They are not reluctant to take the remedial classes as per the need of students. They are fascinated using various teaching methods like class interaction, discussion, departmental seminar, home assignment as a process of learning etc. are adopted to Substantiate lecture method. Each and every teacher is having lesson plan on their concerned subject topic etc. For effective teaching- the faculty/teachers employ adaptivity, student engagement, direct instruction, practice, formative assessment with immediate feedback and student explanation learning.

In term evaluation methods the college adopts many evaluation methods like internal exams, assignments and viva etc, as per the guidelines of the affiliating University.

Total no. of faculty members is 23, out of 23 only 13 posts are latest provincialized, Yet the rest- of the faculty members are also honestly-impacting teaching equally. The college also encourages the faculty to participate in various faculty development programmes A Few of the teachers have participate in national/International Seminars/ Conferences and a good number of teachers have participated in different Orientation programmes, Refreshers Courses, Faculty Development Programme, Faculty Induction Programme, etc.

"In respect of Infrastructure, the college is not getting any govt.fund, so, it is fully not able to provide sufficient space and facility to the students. Yet it has been making full efforts to develop its infrastructure. Limited Seat capacity, limited- rooms, but with patience and tolerance it is providing or disseminating knowledge to the students. Fruitfull- teaching and learning is the solefocus of the institution. It has separate principal's room and a distinctive IQAC closet, and a teacher'scommon room.

Student Support and Progression

The college also cares students support and progression by student mentoring and Support. In each semester, against 20 Students 1 Mentor is designed, for better Support and progression of the students. Thus, our collage

has in total 21 Mentors out of 373 students. Fruitful communication and better counselling are well maintained. Regular remedial classes are taken for the weaker students in order to bring improvement in their academic performance the multiple cells are working for the overall betterment of the performance of the students. Career guidance cell is convening/arranging meeting in which students are inspired. Parents / guardians meet are held usually to promote understanding and reporting the formative performance of the students, the college is hopefully going to take an initiative in the field of college literary forum. Besides it has wall magazine which is the source of creativity.

Governance, Leadership and Management

The college is inclined to governance leadership, and Management. It has a well-structured governing body and management helps to find and address gaps in practice and efficiently implement proper counter mechanism on time. The principal of the college. is strict, disciplined and the most responsible who plays pivotal role in the institutions not indifferent at designing and implementation of plan and policies of the college. She has a well co-ordination and polite-cooperation, while setting internal policies and programs of the college with the association of IQAC co-ordination. Our college is affiliated to G.U. Being an affiliated college, our course structure and the content is designed by the parent university as per the UGC guidelines. The college is now operating only one stream, e.g.Arts . The college currently does not have multiple entries and exit in the offered programmes . Alhaz Sunai Bibi Choudhury college is ready to adopt NEP 2020 in multidisciplinary programmes and Interdisciplinary courses as soon as our Affiliating University gives us the opportunity.
2. Academic bank of credits (ABC):	Academic Bank of Credits (ABC) : Academic Bank of Credits (ABC) is a virtual store that maintains date about the credits earned by students throughout their educational life, opening ,closing and validating the academic accounts of students , accumulation ,credit verification and credit / transfer /redemption of students . The scheme has the provisions of creating a digital infrastructure that will store the academic credits earned by the students of various higher education institutes within the country.
3. Skill development:	Skill Development: Our college is already offering the skill courses as per CBCS scheme set up by Gauhati University from semester III to VI, in various programmes our college is ready to adopt and offer various skill development programmes that will be offered in the New Syllabus for NEP2020 by our Affiliating university or as per the framework done by the government of India .
4. 5. Focus on Outcome based education (OBE):	For outcome based Education, the institution has taken initiatives on Add on Course or Certificate course programme so that it creates outcome based educations to the students apart from academic course. Plant and Nursery management, Assamese DTP, Pickle making, Weaving and Cutting, Communicative language learning etc. are taught according to the requisite of employability in the community. To meet the NEP, The college has implemented interdisciplinary programmes and interdepartmental programmes focusing on Outcome Based Education.

Distance education/online education:	Distance learning, or distance education or online learning form of education in which the main elements include physical separation of teachers and students during instruction and the use of various technologies to facilitate student teacher and student-student communication. Our institution of course , planning to do the same in future ,as the institution has recently been provincialized, and only a few posts are sanctioned under Assam Govt. For this Full Time Teachers are needed and the financial condition of the college ought to be geared up. However, the college is having minimum level of platforms like Google Class Room, Google Meet, WhatsApp group through which the required materials are given.

Curriculum Delivery and Planning Process.

1. IQAC conducts a meeting at the beginning of every academic year to verify the syllabus of each subject.

2. An Academic Plan (Academic Calender of the College) is prepared by the Academic Committee every year on the basis of academic calendar of the University. The departmental academic plans are displayed on the departmental boards.

3. The Prospectus is designed by the Prospectus Committee. It paves information regarding the programs and courses, the details of programs outcomes, specific outcomes, course outcomes, syllabi, weightage of internal and external examinations are communicated through College Website. Sessional question papers are available in the College Website.

4. Departmental Academic Log Book, Departmental Routine, Daily Class Routine, Concerned Departmental Lesson Plan, Departmental Observational Days (National/ International) are prepared for effective teaching/ learning of the students. Teachers' activities are monitored by Google sheet.

Curriculum Implementation Process:

Every HODs of the concerned department convene monthly meeting with the concerned staff regarding lesson plan/ course plan progress report, remedial classes are taken as required, class/ unit test/ home work etc. are taken.

1. Faculty members use Learning Management systems and platforms like Google Classroom,

- students can access video lectures of the activity.
2. For effective learning of the students, concerned departments integrate Resource Person/ Guest Faculty visits are done.
 3. Departmental Trip/ Visit, Quiz Competitions, Meet with Industrial Expert etc. are organized.
 4. Remedial Classes/ measures are conducted for slow learners and small reward system policy to imbibe the fast learners are entertained.
 5. The feedback regarding the curriculum from the students, teachers, parents, employees are usually taken.
 6. For the newly introduced courses, Faculty Programmes are being organized.

The Institution adheres to the Academic Calendar including for the conduct of CIF.

As per Affiliating University Regulation, the continuous assessment in theory subjects are conducted as follows:

1. Internal Assessment (IA) is based on – as

1. Sessional Exams
2. Assignments
3. Attendance

IA is 20% of total marks.

1. In Non- CBCS courses, there are two Unit Tests of 20% marks each paper (Major and General).
2. The college conducts one sessional exam each semester for 30 or 20 marks for the convenience of setting questions and the marks secured by the students are proportionately converted to out of 10 marks. The question papers of the sessional examinations are set by the concerned teachers and the evaluated answer scripts are analyzed with the students. The highest marks achievers are inspired with some book/ pen as reward and lowest marks achievers are given remedial measures to cope with the rest.

Response :

Every year in the beginning of the new academic session starting from June to next higher level semester students and the newly admitted students are given a broad view of the curriculum to be followed in their respective semesters by the faculty of all the departments. Some of the students may take up major/ honors programmes in such subjects which may not have been studied by them at the 10+2 level. So, introductory lectures are delivered to assess and understand the knowledge level in the concerned Subject. Faculties of respective departments facilitate the students to collecting the Syllabus of the concerned subject. In case of slow learners, teachers try to identify the hindrance factors thereby helping to clear the concepts both in classrooms and also during off periods. Depending upon the requirements, tutorial classes are taken for clarifying doubts and explaining the difficult topics of the curriculum.

Advance learners are provided standard textbooks and additional reference materials in the form of PDF format in the departmental WhatsApp Groups and also in the sectional Google Class Rooms.

Field visits/Excursions are carried out in different parts of Assam .Participation in such activities not only lead to subjective knowledge gain, but also helps the students in learning other life-skills exposure.

The college has taken up many activities. Besides cultural events and competition departmental wall magazines add to the participative learning of the students.

Some departments also organizes institutional level programmes like World Philosophy Day(Department of Philosophy),National Education Day(Department of Education),World Mental Health Day(Department of Psychology) and Constitution Day(Department of Political Science).The Department of English has enhanced the learning experiences of the students through screening of documentary films. Students also participate in Annual College Week, Inter-College Youth Festival and earned laurels.

Two awards are given for the best graduate of the college every year. 2.5 Evaluation Process and Reforms

2.5.1 Mechanism of internal/ external assessment is transparent and the grievance redressal system is time- bound and efficient

Response:

The college undertakes internal evaluation in accordance with the guidelines issued by the Gauhati university. Sessional examinations are held once per year by the respective departments. In order to undertake internal assessment of the students. Continuous evaluation procedure is followed for practical papers.

For smoothly conducting the internal as well as term end examinations, separate examinations committees are appointed by the institution. Teachers , both permanent as well as full time faculty members, are nominated in the Examination Committees on rotation basis. Sessional examinations are conducted as stipulated in the academic calendar of the affiliating University. Evaluated answer sheets of sessional examinations are shown to the students so that they learn to rectify their omissions in the future examinations.

As per the University directives, internal examinations are appointed for assisting the external examiners who are appointed by the university, for conducting the practical and viva voce examinations.

The college uploads the regulations, curricula and syllabi of all the programmes offered in the official website for easy access by the students and faculty members.

The college undertakes to conduct internal evaluation in accordance with the norms and guidelines of Gauhati University. Question papers are submitted through HODs of all the departments. The said examinations are supervised by the faculty members of the concerned departments. Syllabus for the internal examinations is communicated to the students in advance by the concerned teachers teaching the different papers or courses.

In order to maintain transparency and accountability to the evaluation process, evaluated answers sheets are shown to the students. Discrepancies, if any, in the evaluation is brought to the notice of the teachers concerned and accordingly necessary corrections are made.

Rules and regulations of internal examinations are displayed in the college notice board along with the Examination Schedule. Full marks and time duration are also printed in the question papers. The attendance record of the students in the examinations is documented in a proper format. Marks list of evaluated answer sheets are documented and thereby submitted to the University through the concerned examination committees.

Grievance related to internal examinations are handled and resolved immediately by the respective HODs and teachers of the departments concerned.

Regarding external term-end exams, faculty members of the respective departments and the administrative officials help them to apply in proper format prescribed by the University, routed through the Principal, for proper re-evaluation and handling of the grievance.

The Governing Body: The college has an effective and well functioning organizational structure and the prime administering authority is the Governing Body. The Body is consists of renowned educationist from the locality, principal, a few selected staff members, guardian members and affiliating University Representatives. The highest authority is the President of the Governing Body, who is selected from among the educationists of the area and is appointed by the DHE, Assam.

Principal: The principal who is in charge of the college is the key person having executing authority of each and every affair of the institute. He/ She is entrusted to implement the directives of Governing Body and is the communicative agent between the Governing Body, Government and the University.

The Staff Unit: The Unit takes adequate measures in implementation of the strategic plans and sometimes also takes decision in view of various affairs of the college.

Committees and Cells: For smooth functioning of the Institute the administration of the college supported by a number of committees and cells.

Recruitment: The initial appointments to the Institute were made by the college Governing Body with the consolidated pay of remuneration Rs 2000/-. Later on, unfortunately after a long struggle at the Venture Level, finally the Govt. of Assam provincialized only 13 posts out of 23 posts in our Institution, this earmarks the weakness of the Institution.

6.3 Faculty Empowerment Strategies

The Institution has effective measures for teaching and non-teaching staff.

- Employees Fund is maintained in the College and financial help is provided to the employees in urgent need.

- The college administration encourages the teacher to apply for promotion without any delay and adheres to the UGC Guidelines for their career advancement.
- Group Insurance is offered to the employees, considering their service conditions for their welfare.

Institutions Performance Appraisal System for teaching and non-teaching staff.

Teacher Performance record: The teachers are asked to record their everyday engagement at the beginning of every academic year. Each and every details related to lesson plan, test, assignments, mentoring, tutoring, remedial classes, leave taken are recorded. The Principal and the Head of the Departments regularly monitor such issues. During the annual academic audit, the management also evaluates these. Teachers are directed to submit teaching plans every semester to ensure time bound implementation of the academic plan proposed with the start of the academic year.

Evaluation by Management: The College has an academic Committee which evaluates the performance of teachers. The teachers are provided a Proforma and at the end of every academic year it is submitted to the academic committee. The committee members occasionally visit each department to evaluate the performance of the teachers.

Objectives of the Practice :

Underlying Principles/ Concepts :

Alhaz Sunai Bibi Choudhury College has selected this practice with the above mentioned aims and objectives. The College believes that as a higher educational institution of the area, it has the responsibility to explore, understand and identify and preserve the different species of Bamboo along with other plants. Accordingly, the College has been undertaking several programmes in this line since the concept of Bamboo species grasped, with active involvement of its people, students, teachers, researchers.

The Context:

The College has carefully observed the people of entire Udali, locality have been transmitting their unique knowledge to Plant and Nursery Management. Constraints/ Limitations faced with executing the Project Work:

- Since it is Muslim Minority dominated area, sunk under prejudice, mischiefs, doubts, illiteracy and Poverty.
- Absence of urge to cultivate and identify any product.
- They are reluctant to be creative and rennovative.
- Deforestation due to rapid rate of population increase which may cause for disappearance of some rare species of Plants and Bamboos.

Evidence of Success :

- Through Field Visit/ Home Visit Programmes, the College has explored, identified and documented – 40 types/ species of plants and Bamboos.
- Through different survey programmes students and teachers could detect and oidentify different medicinal herbs/ plants.
- It has created an awareness among the locality and increased the level of employability.

Problems encountered and Resources required :

- Lack of available fund to carry out these activities.
- Shortage of time to plan and carry out these activities in a large scale.Lack of research oriented equipment.
